

Friends of Riding Mountain National Park Busker Program

HOW TO APPLY

1. **Complete an application**
 - a. available at the Friends of RMNP Learning Centre (154 Columbine, Wasagaming)
 - b. online at www.friendsofridingmountain.ca
2. **Set up an audition time by**
 - a. Calling Friends of RMNP (204.848.4037)
 - b. Emailing friends.rmnp@mymts.net
3. **Show up for audition** with application fee (\$10.00 - Cash, Debit, Visa, MasterCard accepted).
No cheques.

REGISTRATION & LICENSING

- 1) ALL new and returning and buskers MUST successfully complete an audition held at the Friends of RMNP Learning Centre
 - **Auditions MUST be pre-booked and can be held throughout the season**
- 2) Applications submitted by performers under the age of 18 must have the signature of a parent or guardian.
- 3) All performances must be of a content and quality suitable for family viewing. **Acts deemed vulgar, in poor taste or offensive are strictly prohibited.**
- 4) **NO AMPLIFIED PERFORMANCES ALLOWED.**
- 5) **A safety plan must be submitted with each application that poses a potential risk to the performer, public or Riding Mountain National Park.**
- 6) Approval for the selling of works of art such as CDs or DVDs must be requested on the audition application. Merchandise can ONLY be sold through the Friends Learning Centre. **Selling of merchandise at Busk Stop locations is prohibited.**
- 7) Successful audition candidates will be issued a Friends of RMNP Busk Pass license that will allow performances at all Busking Stations. **Absolutely NO performances** will take place within Riding Mountain National Park and the community of Wasagaming that are not at designated Friends of RMNP Busk Stop areas.
- 8) Performance season runs from date of audition and acceptance until JUNE 1st, 2025.
- 9) Friends of RMNP Busk passes must be displayed clearly during all performances.
- 10) **Performances are not allowed without a valid Friends of RMNP Busk Pass. Passes are NON-TRANSFERRABLE.**

PERFORMANCES

- 1) Acts must be of similar quality and content as that of the audition.
- 2) All musical acts must maintain a repertoire equivalent to two (2) - 30 minute sets (60 minutes of different material).
- 3) Performances are permitted at designated Friends of RMNP Busk Stops only.
- 4) Management retains the right to relocate/remove or close Busk Stops at their discretion. Scheduled events and programs have priority over busker performances.
- 5) Performers must not exceed six performances per calendar day.
- 6) Each set must not exceed 60 minutes including setup and take down time.
- 7) Performances are to begin on the hour (this includes set up and take down).
- 8) Performers may perform a maximum of 2 performances per day per busk stop location (unless advance permission is granted).
- 9) Consecutive performances are NOT allowed at any Busk Stop (unless advance permission is granted).
- 10) Performances can take place daily from 11:00 a.m. to 10:00 p.m. at any of the five (5) identified Busk Stop locations.
- 11) Performance appreciation is at the discretion of the audience (no solicitation, signage or interception).
- 12) Buskers are ambassadors of Friends of RMNP and Riding Mountain National Park, appropriate attire and professional conduct is expected at all times.
- 13) Having a Friends of RMNP Busk pass is a privilege. A busk pass may be revoked at any time at the discretion of Friends of RMNP or Riding Mountain National Park management.
- 14) Smoking is not permitted at any Friends of RMNP Busk Stop.

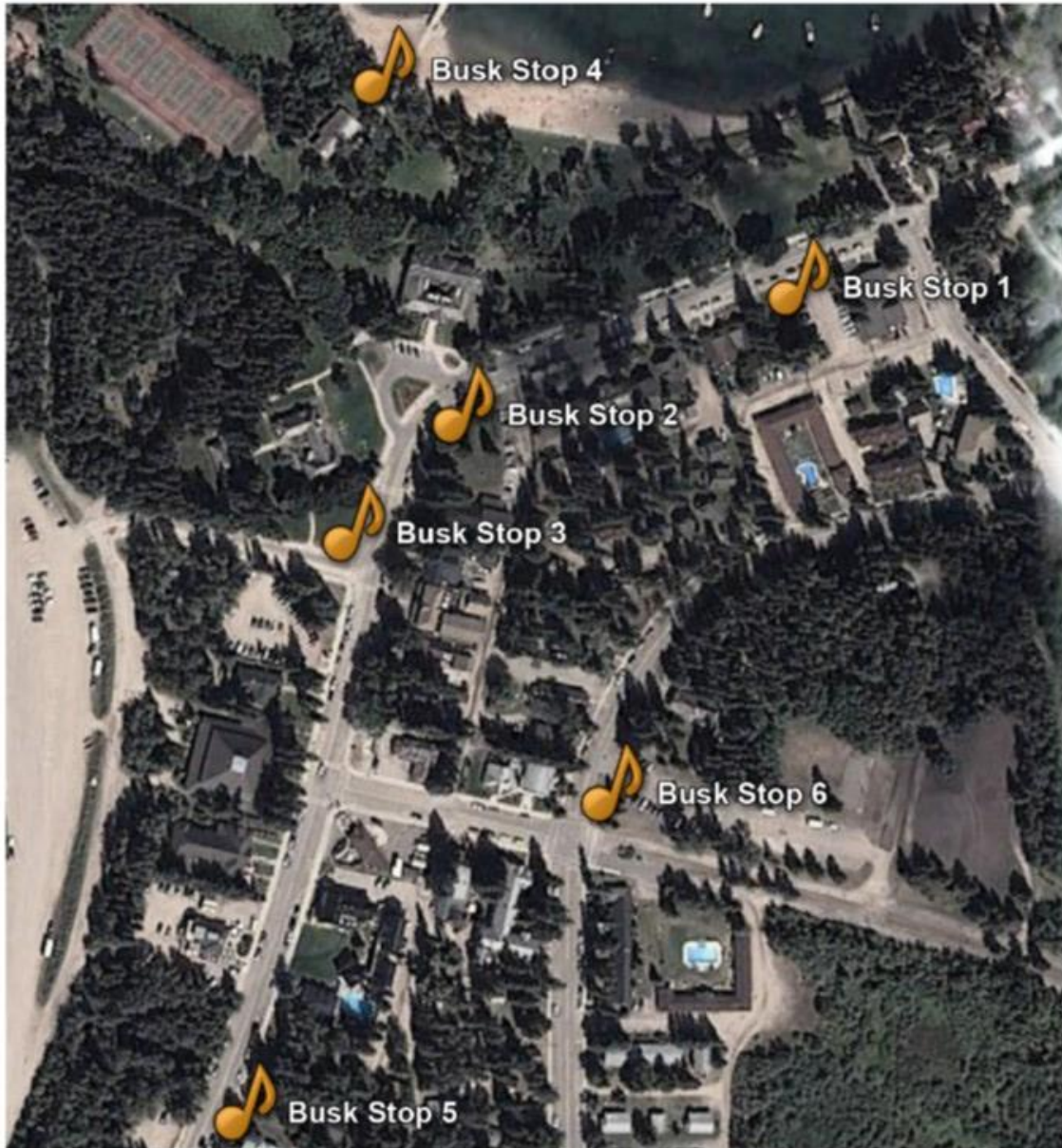

BUSKER RULES & REGULATIONS

1. Valid Friends of RMNP Busk Pass must be displayed and visible during all performances (only one Busk pass will be issued per group).
2. Performances are permitted at designated Friends of RMNP Busk Stops only. **Absolutely NO performance** will take place within Riding Mountain National Park and the community of Wasagaming (including businesses) that are not designated Friends of RMNP Busk Stops
3. Friends of RMNP and Riding Mountain National Park retain the right to relocate remove or close Friends of RMNP Busk Stops at their discretion. Scheduled programming has priority over busker performances.
4. All performances must be of a content and quality suitable for family viewing. **Acts deemed vulgar, in poor taste or offensive are strictly prohibited.**
5. Performers must not exceed six performances per calendar day.
6. Each set must not exceed 60 minutes including setup and take down time.
7. Performances are to begin on the hour (this includes set up and take down).
8. All musical acts are required to maintain a repertoire of two (2) – 30 minute sets (60 minutes of different material).
9. Performers may perform a maximum of 2 performances per day per busk stop location (unless advance permission is granted).
10. Consecutive performances are NOT allowed at any Busk Stop (unless advance permission is granted).
11. **Performances can take place daily from 11:00 a.m. to 10:00 p.m.** at any of the five (5) identified Busk Stop locations.
12. **No amplified performances allowed.**
13. **A safety plan must be submitted with each application that poses a potential risk to the performer, public or Riding Mountain National Park.**
14. Performance appreciation is at the discretion of the audience (no solicitation, signage or interception).
15. Buskers are ambassadors of Friends of RMNP and Riding Mountain National Park. Appropriate behaviour and attire are expected at all times.

16. Smoking is not permitted at Friends of RMNP Busk Stops.

17. The Friends of RMNP Busk Pass is non-transferrable. Transferring of Friends of RMNP Busk Pass will result in immediate termination.

18. Busker's merchandise can ONLY be sold through Friends Learning Centre location. **Selling of merchandise at Busk Stop locations is prohibited.**
